This seminar introduces participants to a specific evidence-based intervention, Child- Parent Psychotherapy. This model is a dyadic attachment-based intervention for young children exposed to interpersonal violence and other traumas, and has been empirically validated for children under age 6. The training will include a review of the theoretical foundation of the model, an overview of assessment protocols, a description of the principles of intervention and core clinical skills that are used. Case presentations and video based clinical vignettes will be used to illustrate key principles.

Goals

Participants will:

- Gain familiarity about Child-Parent Psychotherapy.
- Increase skills in using the model with young traumatized children and their families.
- Increase understanding of assessment processes and tools used in treating children exposed to trauma.

Through a series of lectures, video-based clinical vignettes, and case discussions participants will be introduced to the principles of assessment and treatment of young children who are exposed to domestic violence or other traumas, using Child-Parent Psychotherapy.
